### **1. Open Meeting –**

**2. Approve August 5, 2025 meeting minutes – moved by CM Partridge, second by CM Becker and carried, CM Thumma voted no.** Spelling of Sol. Buechler’s name should be corrected.

**Approve amended June 6, 2025 meeting minutes – moved by CM Partridge, second CM Becker and unanimously carried.**

### **3. Engineer’s Report –**

a. ADA Ramps – still waiting for PennDot to close out the permit. Property owner to be billed for engineer’s time upon closure of permit.

b. Status of Road Projects – Bid awarded and work to be completed by 10/31/25.

c. Sherwood Dr. sink hole – Still checking to find someone to examine area.

d. Status of Nottingham Village Subdivision – to be reviewed at September 23 Planning Commission mtg.

**On a motion by CM Thumma, second by CM Pugh and unanimously carried,** the engineer’s time to assess the water main break on Robin Hood Dr. will be billed directly to York Water Co.

**SKIPPED TO 9E – On motion by CM Partridge, second by CM Becker and unanimously carried,** Resolution 2025-07 LSA Cat 4 Grant was approved along with the \$100 application fee for submittal.

## 5. Matters of the Borough

a. Fire – questioned the changes to the run cards (call boxes). Discussion ensued and the Fire Co is to recommend changes, present the information to CM Partridge who will review, sign and return to YCC for changes.

b. Sewer – Mayor Mundorf & CM Thumma again indicated their thoughts on paying down the sewer loan. CP Martin received a 3<sup>rd</sup> party review advising not to make any changes at this time and now recommended CM Thumma and the Mayor obtain a 3<sup>rd</sup> party review of their choosing.

c. Highway – Robin Hood Dr damaged from Electric bike. Owner of bike will be billed for repairs.

d. Building – CM Baldauf started the sealing around the building.

e. Police – Chief Lash presented report with 31 calls, no accidents, 14 traffic stops and 13 EMS calls. Time used was 55.75 hours leaving 29 hours in reserve.

c. Resolution 2025-05 – Kindness Week Proclamation – moved by CM Thumma, second by CM Partridge and unanimously carried, Resolution passed and signed..

d. Resolution 2025-06 – Zoning Hearing Appointments – moved by CM Partridge, second by CM Pugh and carried – CM Thumma voted no – Resolution passed and signed.

f. Approve Newsletter – CP Martin is to finalize for approval at the October meeting.
